Madam/Sir,

I am to refer to D.O. letter dated 2nd December, 2025 of Secretary, Ministry of Education, Govt. of India on the subject cited above, vide which it is informed that the 9th edition of "Pariksha Pe Charcha", the unique interactive program of Hon'ble Prime Minister, Shri Narendra Modi with students, teachers and parents will tentatively be held in January 2026. This event has been successfully organized for the last eight years by the Department of School Education & Literacy, Ministry of Education in coordination with all the States and other Ministries.

Ministry has informed that over 5 crore students, parents and teachers participated in PPC-2025- a kind of nationwide Jan Andolan.

In order to select participants who will be featuring in the Pariksha Pe Charcha 2026, an **online Multiple Choice Question (MCQ) competition is being conducted at <https://innovateindia1.mygov.in/> from 1st December, 2025 to 11th January 2026 for children studying in classes from 6 to 12, teachers and parents.** All the participants will receive a participation certificate.

The competition is the mode through which we invite students, parents and teachers to be a part of PPC 2026 and to be able to frame their questions to be addressed to the Hon'ble Prime Minister. Selected questions, shortlisted by NCERT, may feature in the programme. The participants who asked questions in the previous editions of Pariksha Pe Charcha are invited by media channels to appear in their programmes. Along the same lines this year's chosen few may get an opportunity to interact with the media.

You are requested to disseminate this information to all AIs/AVIs of NIOS under your jurisdiction to participate in the competition as per the activities under PPC-2025, which are as follows:

- (i) The AIs/AVIs are requested may adopt other innovation measures to propagate and promote this significant initiative of Hon'ble Prime Minister towards reducing exam stress.
- (ii) Request the learners to use their own social media handles and #PPC2026 to disseminate the event, along with their own preparations for the event.
- (iii) The AIs/AVIs are requested to encourage students to make their own posters/creatives/videos, etc. and post accordingly. The selected creatives/videos from among these shall also be exhibited on the MyGov platform.


